



## **Economic Development Fund Discretionary Grant Program**

**Organization:** La Pine Park and Recreation District

**Organization Description:** This is an Oregon Special District governed by a five-member elected board responsible for delivering recreational programs and facilities to the Greater La Pine Community, an 85 square mile area of South Deschutes County. The District is funded through a combination of fees, facility rentals, lease income and a recycling program. The District offers programs such as seasonal craft and art shows, sports, summer day camp and a two-day music festival.
