Sheriff Larry Blanton has announced his resignation/retirement, effective July 1, 2015. Pursuant to ORS 236.210, the BOCC is to appoint a person to perform the duties of the Office of Deschutes County Sheriff until the vacancy is filled by election (at next General Election).

Sheriff Blanton and Captain Nelson attended the BOCC Business Meeting on February 2, 2015 and explained the plans for transition, including letters of support for Shane Nelson from multiple officials within the local law enforcement community.
