BACKGROUND AND POLICY IMPLICATIONS:

On July 2, 2014, the Board held a public hearing on Community Development Department File No. TA-13-4, which is a proposal by Central Oregon Irrigation District to amend Deschutes County Code 19.20.020 to add the operation, maintenance, and piping of existing irrigation systems operated by an irrigation district as a use permitted outright in the SR 2 ½ zone. At the end of that hearing, the oral record was closed but the written record was left open.
