BACKGROUND AND POLICY IMPLICATIONS:

The County participates in two programs sponsored by the Government Finance Officers Association (GFOA). The first is the Certificate of Excellence in Financial Reporting. This awards program evaluates the annual financial report known as the CAFR against a set of national criteria for government financial reporting. The second is the Distinguished Budget Presentation Award. This program evaluates the County's annual Budget document against a set of national criteria that include content related to budget and financial policies, financial planning, operations and communications.

Roger Dawes, the Controller for Washington County and the GFOA representative for Oregon is here this morning to present both awards. Roger is also a past president of the Oregon Government Finance Officers Association. He will be presenting the CAFR award to Jeanine Faria and the Budget Award to Teri Maerki, long time members of the Deschutes County Finance Department.

Continued participation in these programs enhances our financial reporting and budgeting practices and aids in the maintenance of the County's bond ratings.



Certificate of Achievement program policy requires that written responses to the comments and suggestions for improvement accompany the next fiscal year's submission. Your written responses should provide detail about how you choose to address each item that is contained within this report. These responses will be provided to those Special Review Committee members participating in the review.

When a Certificate of Achievement is awarded to a government, an Award of Financial Reporting Achievement (AFRA) is also presented to the individual(s) or department designated by the government as primarily responsible for its having earned the Certificate. Enclosed is an AFRA for:

Continuing participants will find a certificate and brass medallion enclosed with these results. First-time recipients will find a certificate enclosed with these results followed by a plaque in about 10 weeks. We hope that you will arrange for a formal presentation of the Certificate and Award of Financial Reporting Achievement, and that appropriate publicity will be given to this notable achievement. A sample news release has been enclosed. We suggest that you provide copies of it to local newspapers, radio stations and television stations. This form should be completed and sent (postmarked) with three copies of your report, three copies of your application, three copies of your written responses to the program's comments and suggestions for improvement from the prior year, and any other pertinent material with the appropriate fee by December 31, 2015.

To continue your participation in the program, it will be necessary to submit your next annual budget document to GFOA within 90 days of the proposed budget's submission to the legislature or within 90 days of the budget's final adoption. Chicago--The Government Finance Officers Association of the United States and Canada (GFOA) is pleased to announce that **Deschutes County, Oregon** has received the GFOA's Distinguished Budget Presentation Award for its budget.

The award represents a significant achievement by the entity. It reflects the commitment of the governing body and staff to meeting the highest principles of governmental budgeting. In order to receive the budget award, the entity had to satisfy nationally recognized guidelines for effective budget presentation. These guidelines are designed to assess how well an entity's budget serves as:

- a policy document
- a financial plan
- an operations guide
- a communications device

Budget documents must be rated "proficient" in all four categories, and the fourteen mandatory criteria within those categories, to receive the award.

When a Distinguished Budget Presentation Award is granted to an entity, a Certificate of Recognition for Budget Presentation is also presented to the individual or department designated as being primarily responsible for its having achieved the award. This has been presented to **Finance Department**

For budgets beginning in 2013, 1,424 participants received the Award. Award recipients have pioneered efforts to improve the quality of budgeting and provide an excellent example for other governments throughout North America.
