Order Amending Public Hearing Date for the \*  
Scott and Pamela Hayes Living Trust \* ORDER NO. 2015-039  
Annexation into the Redmond Fire and \*  
Rescue District \*

WHEREAS, in Order 2015-039, the Board of County Commissioners (“Board”) accepted the petition of Scott and Pamela Hayes Living Trust to annex into the Redmond Fire and Rescue District (“District”) and set a hearing date of August 24, 2015; and,

WHEREAS, the hearing must be rescheduled and no notice of the hearing has been published or mailed as of the date of this order; and,

WHEREAS, the next available hearing date within the statutory time frame is August 26, 2015; and,

WHEREAS, the Board chooses to also require publication notice for special district annexations; now therefore,

THE BOARD OF COUNTY COMMISSIONERS OF DESCHUTES COUNTY, OREGON, HEREBY ORDAINS as follows:

Section 1. Order 2015-038 is amended such that the public hearing regarding the Hayes annexation to the District shall be held on August 26, 2015, at 10:00 a.m. at 1300 NW Wall Street, First Floor Hearing Room, Bend, Deschutes County, Oregon.

Section 3. Notice of Hearing shall be given in substantially the form set forth in Exhibit “2,” attached hereto and by this reference incorporated herein. The Legal Department shall cause the notice to be published in The Bulletin on August 11, 2015 and August 21, 2015 and posted August 11, 2015, in three public locations within the county as follows: One notice shall be posted on or near the doors of the meeting room of the Board of County Commissioners; one notice upon any official bulletin board customarily used for the purpose of posting public notices within the county; and one notice shall be posted upon any official public bulletin board customarily used for the purpose of posting public notices within the district. Notices posted shall be for not less than five (5) consecutive days.

Section 4. The Director of the Deschutes County Community Development Department shall cause to be filed with this Board prior to August 26, 2015, a land use compatibility statement regarding this proposed special district annexation as contemplated in ORS 197.175 and 199.462, and any other applicable statutory authority.
