Consideratin of Signature of Document No. 2015-532 amending Document No. 2011-648 for operational service at Negus Transfer Station.

**BACKGROUND AND POLICY IMPLICATIONS:**

We are currently under contract with Deschutes Transfer Company for assistance in the operation of Negus Transfer Station in Redmond. The contractor provides an employee and equipment at the site to assist with directing traffic, managing the placement of trash and recyclables, and coordinating transport of waste and recyclables to Bend. The contractors assets also perform work that benefits themselves and the franchise collector as well. Fees paid under the agreement represent about 1/2 the cost of assets for this reason. Increased traffic at the site requires more effort for work performed for Deschutes County. This contract amendment increases the fee paid and provides for 1 full time employee for County work and continues to split the cost of equipment at the site. The amendment also renews the term of the agreement to 5 years with provisions for possible extensions. It is estimated that the proposed fees represent approximately \$10,000 in savings compared to the use of County personnel and equipment.

**FISCAL IMPLICATIONS:**

The contract amendment increases our fees by \$28,651.56 per year. The new annual cost is\$98,251.56

**RECOMMENDATION & ACTION REQUESTED:**

We have had an excellent experience with this contractor in this arrangement. The amendment still provides a cost savings to the Department. I recommend signature of Doc. No. 2015-532

Services include directing traffic, assisting customers, consolodating wood waste and yard debris with contractor furnished backhoe. compaction efforts in trash trailers with backhoe, removing contamination from recyclables..

**Background & History:** We entered into a 5 year contract in 2011 for services when the facility moved to a 7 day per week operation. This allowed us to expand operations without adding employees. The contractor supplies an employee and equipment who's efforts benefit the Department, however only about half of the time is dedicated to our operations. The other time spent by the employee is for efforts that are not associated with normal operations for the faciity. Some efforts such as compaction of trash in the trailers is a benefit to the contractor, so we have split the cost of the employee and equipment with the contractor. Increased traffic to the site have required more of an effort for tasks that we are responsible for. This document amends our original agreement, raising the amount paid to cover the increased efforts, and extending the expiration date of the agreement to 2020 with provisions for extension. The new fee represents the full cost of 1 contractor employee and half the cost of equipment. The original agreement was awarded as a result of an RFP.

AMENDING DESCHUTES COUNTY CONTRACT NO. 2011-648**

THAT CERTAIN AGREEMENT, Deschutes County Contract No. 2011-648 dated October 26, 2011, by and between DESCHUTES COUNTY, a political subdivision of the State of Oregon ("County") and DESCHUTES TRANSFER COMPANY ("Contractor"), is amended, effective upon signing of all parties, as set forth below. Except as provided herein, all other provisions of the contract remain the same and in full force.

County's performance hereunder is conditioned upon Contractor's compliance with provisions of ORS 279B.220, 279B.225, 279B.230, and 279B.235, which are hereby incorporated by reference. In addition Standard Contract Provisions contained in Deschutes County Code Section 2.37.150 are hereby incorporated by reference. Contractor certifies that the representations, warranties and certifications contained in the original Contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.

The above listed contract is amended as follows:

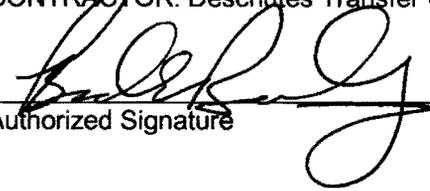
Exhibit 1. Statement of work, compensation payment terms and schedule

4. Consideration

- a. County shall pay Contractor on a fee-for-service basis at the maximum rate of \$8,187.63 per month.

**Effective Date and Termination Date.** The effective date of this Contract shall be July 31, 2015 or the date, on which each party has signed this Contract, whichever is later. Unless extended or terminated earlier in accordance with its terms, this Contract shall terminate when County accepts Contractor's completed performance or on July 31, 2020, whichever date occurs last. By mutual agreement prior to termination, this Contract may be extended for three additional years to July 31, 2023. Contract termination shall not extinguish or prejudice County's right to enforce this Contract with respect to any default by Contractor that has not been cured.
