BACKGROUND AND POLICY IMPLICATIONS:

Consideration of Resolution #2015-106. The FY 2016 budget does not include appropriation for the commissions and fees incurred as a result of selling real property. Such costs were incurred on the sale of property on Highway 97 (known as the Design Center) in Redmond. The County has also entered into a contract with City of La Pine for the City to manage the industrial properties and split all sales and lease proceeds equally. An appropriation transfer is necessary to disburse these funds to the City.
