TITLE OF AGENDA ITEM:

Consider resolutions to approve that the area within the boundaries of the Countywide Law Enforcement District and the Rural County Law Enforcement District be included in a proposed new 911 Service District.

BACKGROUND AND POLICY IMPLICATIONS:

In order for the Service District to change its permanent levy rate, the current District must be dissolved and a new District must be formed to take its place with a revised permanent levy rate. This process may be accomplished concurrently with a single ballot measure. To place the measure on the May 2016 ballot, resolutions are needed from two-thirds of the public safety entities in the District's service area on a population basis. The BOCC serves as the Governing Board for the two law enforcement service districts.

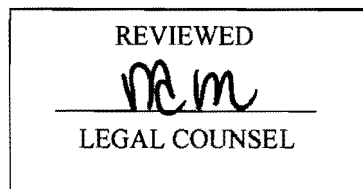

A RESOLUTION APPROVING THE DESCHUTES COUNTYWIDE LAW ENFORCEMENT DISTRICT BE INCLUDED IN A NEW COUNTYWIDE 911 SERVICE DISTRICT – to be known as **DESCHUTES COUNTY 911 SERVICE DISTRICT**; INCLUDING WITHDRAWAL OF TERRITORY FROM THE EXISTING DESCHUTES COUNTY 911 COUNTY SERVICE DISTRICT UPON VOTER APPROVAL OF THE NEW DISTRICT, AND THE DISSOLUTION OF THE EXISTING DISTRICT UPON THE WITHDRAWAL OF TERRITORY FROM THE EXISTING 911 SERVICE DISTRICT.

Pursuant to ORS 451.605(3), the Board of County Commissioners of Deschutes County, Oregon, acting as the Governing Body of the Countywide Law Enforcement District HEREBY RESOLVES and approves that the area within the boundaries of the Countywide Law Enforcement District be included in the proposed new District; the withdrawal of territory from the existing District upon voter approval of the new District, to include a new maximum permanent tax rate of \$0.425 per thousand dollars of taxable assessed value, and the dissolution of the existing District upon the withdrawal of territory from the existing 911 Service District;

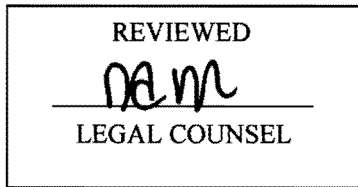

A RESOLUTION APPROVING THE RURAL LAW ENFORCEMENT DISTRICT BE INCLUDED IN A NEW COUNTYWIDE 911 SERVICE DISTRICT – to be known as ***DESCHUTES COUNTY 911 SERVICE DISTRICT***; INCLUDING WITHDRAWAL OF TERRITORY FROM THE EXISTING DESCHUTES COUNTY 911 COUNTY SERVICE DISTRICT UPON VOTER APPROVAL OF THE NEW DISTRICT, AND THE DISSOLUTION OF THE EXISTING DISTRICT UPON THE WITHDRAWAL OF TERRITORY FROM THE EXISTING 911 SERVICE DISTRICT.
