Whereas, the Board of County Commissioners ("Board") agreed to hear this appeal *de novo* under Order No. 2015-030; and

WHEREAS, the Board conducted public hearings on January 27, 2016 and February 29, 2016 and established post-hearing periods, for the submittals of written materials; and

WHEREAS, Appellant, Kine and Kine Properties, has requested a re-opening of the public hearing record for the submittal of written materials, and

WHEREAS, the Board has determined that additional testimony and information regarding this matter is of paramount importance in this proceeding; and

WHEREAS, the Board may at its discretion reopen the record in accordance with DCC 22.24.160; and,

WHEREAS, the applicant has agreed in writing to an extension of the 150-day time limit accordance with DCC 22.24.160(A); therefore,

THE BOARD OF COUNTY COMMISSIONERS OF DESCHUTES COUNTY, OREGON, HEREBY ORDERS as follows:

Section 1. The public hearing on file numbers 247-14-000391-TP; 392-SP; 393-LM, 207-A, and 085-MA shall be reopened for written evidence, but only for the purpose of submitting into the record the evidence and argumentation pertaining to the effect of the "Mile Post 1" and Points West subdivisions on the unit count and open space requirements under the Widgi Creek Master Plan.

Section 2. The written record for all parties for new evidence and argumentation is extended to 5:00 p.m. October 19, 2016, but only for evidence and argumentation submitted per Section 1.

Section 3. The written record of all parties is extended to 5:00 p.m. October 26 2016, but only for response to the evidence and argumentation per Section 2.

Section 4. The written record for final argument by the applicant is extended to 5:00 p.m. November 2, 2016.

Section 5. The Planning Division shall give written notice to all parties that the record is being reopened, in accordance with DCC 22.24.160(B)(2).
