Notice is hereby given that on Tuesday, November 3, 2020, a measure election will be held in Deschutes County on the question of whether to annex land into the West La Pine Livestock District.

---

**CAPTION:** Annexation of Land into West La Pine Livestock District (Petition 2)

**QUESTION:** Shall the boundaries of the West La Pine Livestock District be modified to include the Petition 2 Annexation Area?

**SUMMARY:** The purpose of this election is to determine whether to annex certain land, referred to herein as the "Petition 2 Annexation Area", into the West La Pine Livestock District, so as to make it unlawful for horses and cattle to run at large within such area. Approval of this measure would add the Petition 2 Annexation Area into the West La Pine Livestock District, but only if that ballot measure annexing the Petition 1 Annexation Area into the West La Pine Livestock District is also approved by the voters.
