

Dear Deschutes County Voter:

This is your November 8, 2016 General Election Voters' Pamphlet provided by your Deschutes County Clerk's office. It includes information about candidates and measures from local jurisdictions within the boundaries of Deschutes County. We have inserted the Deschutes County Voters' Pamphlet in the State Voters' Pamphlet to save on mailing costs. The State Voters' Pamphlet includes federal and state candidates and measures.

This pamphlet contains the ballot measures and explanatory statements designed to provide you with impartial and fair information. It also contains paid arguments for or against certain measures. Candidates may also pay to place a statement in the pamphlet to provide you with additional information about them.

Ballots will be mailed on Wednesday, October 19, 2016, to each registered voter. Here are a few things you should know:

- We are recommending that the last day to mail your ballot is Tuesday, November 1. Beginning Wednesday, November 2, ballots should be taken to an official drop site.
- Voted ballots MUST be received at our office or an official drop site location by 8:00 pm, Tuesday, November 8, 2016 to be counted. Remember to sign your ballot envelope.
- The signature on each voter's return envelope is verified against the voter's signature on file. The signature must match for the ballot to be counted.
- The names of the candidates on your ballot will appear in random alphabetical order. In accordance with ORS 254.155, random ordering of the letters is conducted prior to each election.
- Not all the candidates or measures in this Voters' Pamphlet will be on your ballot. Your residence address determines those districts for which you may vote. Your official ballot will contain only those issues on which you are eligible to vote, based on where you live.
- Not all candidates submit information for the Voters' Pamphlet so you may have candidates on your ballot that are not in the Voters' Pamphlet.
- This Voters' Pamphlet is online at <u>www.deschutes.org/clerk.</u> After 8:00 pm on election night, preliminary election results will be posted online at <u>www.deschutes.org/electionresults</u>.
- If a ballot was delivered to your residence for someone who should no longer be receiving a ballot at your address, please write "RETURN" on the envelope and place it back in your mailbox.





Returning your Ballot:

Beginning Wednesday, November 2, ballots should not be mailed but will need to be taken to an official ballot drop site.

Signing your Ballot Return Envelope:

Remember to sign your ballot return envelope. The signature on each voter's return envelope is verified against the voter's signature on file. The signatures must match before a ballot can be counted. If your signature has changed, please update your voter registration.

Voting Information

Registering to Vote

To be eligible to vote in the November 8, 2016 General Election, a completed voter registration card must be postmarked by Tuesday, October 18, 2016.

To Register To Vote In Oregon, You Must Be:

- 1. A resident of Oregon.
- 2. A United States citizen.
- 3. At least 18 years old by election day.

You Must Update Your Registration If:

- 1. Your residence or mailing address changes.
- 2. Your name changes.
- 3. You wish to change your party affiliation.

Important Note: If you have moved or your name has changed and you have not yet updated your registration, you are still eligible to vote. Contact the Deschutes County Elections office, 541-388-6547 for further information.

Voters With Disabilities:

If you are unable to vote your ballot without assistance, contact the Deschutes County Elections office at 541-388-6547. We will provide two persons to assist you in voting. To assure your voted ballot is received by election day, contact the elections office early to arrange for assistance. You may also select someone else of your own choice to assist you.

Voting Instructions

Examine your official ballot and vote it

Examine your official ballot and locate the candidate or measure response oval of your choice for each contest. To vote you must blacken the oval () completely with a pen (black or blue ink) next to your choices.

Review your ballot

Ensure you correctly marked your choice for each contest. Your official ballot may contain contests printed on both sides of your ballot.

Prepare to return your ballot

Place your ballot in the return envelope. You may use the optional secrecy sleeve, but it is not required. Election staff will ensure the secrecy of your ballot. Read the voter's statement on the return envelope and sign it on the signature line. Your ballot will not be counted if the return envelope is not signed. Every signature is checked against the registration signature on file and the signature must match for the ballot to be counted.

Return your ballot

By mail: Attach first-class postage to the signed and sealed return identification envelope. Mail it as soon as possible to arrive at Deschutes County Election's Office no later than 8:00 pm on Election Day. Postmarks do not count.

At an official drop site: Deliver the signed and sealed return identification envelope to an official drop site no later than 8:00 pm on Election Day. Postage is not required if delivered to an official ballot drop site location.





Your vote **will not count** for that candidate or measure.




You do not have to vote on all contests. Those you do vote on will still be counted.

Ballot Title 9-109

10 Year Capital Projects Local Option Tax

QUESTION: Shall the District levy \$0.90 per thousand of assessed value for 10 years for sealing roads beginning 2017/2018? This measure may cause property taxes to increase more than three percent.

SUMMARY: This measure would finance capital construction and improvements of 2.3 miles of existing Deschutes River Recreation Homesites Unit 6 Special Road District roads. The project would seal approximately 27,840 square yards of road serving the District at a cost of \$135,000 which would be amortized over the 10 year life of this measure. Funds will be used to seal portions of Foster Road, Silver Fox Drive, Bench Leg, Bear Lane, Silver Fox Drive, and Mt Sheep Lane and all of Caribou and Cub Drive. All improved lots within the District would be within 1,500 feet of sealed roads. The District has experienced continuing growth and increased local and commercial traffic. The District receives ~\$23,000 per year to maintain approximately seven miles of road. This measure would allow imposing up to \$0.90 per \$1,000 of assessed value which is estimated to raise \$17,100 in year one, \$17,528 year two, \$17,966 year three, \$18,415 year four, \$18,875 year five, \$19,347 year six, \$19,831 year seven, \$20,327 year eight, \$20,835 year nine, and \$21,356 year ten.

Explanatory Statement

Acting on the recommendation of the Deschutes River Recreation Homesites Unit 6 Special Road District meeting of July 25th, 2016 and its appointed sub-committee the Road District Board of Directors refers this measure. The measure would provide funds to Otta seal approximately 27,840 square yards of roads serving the subdivision. This would improve emergency vehicle ingress/egress, minimize rough and wash board roads, improve dust abatement, and improve the local environment by reducing air particulate pollution.

The subdivision has grown to approximately 130 houses with increases in traffic over the last 15 years. Improvement to the roads has been limited due to lack of funding. About \$5,000 of the annual budget is used for snow removal leaving about \$18,000 per year to maintain the seven miles of road within the District's authority.

The \$135,000 capital improvement project payable over 10 years with a tax option levy would provide funds to Otta seal:

Foster Road from State Rec Road for 2,684 feet Silver Fox Drive from Foster to Cub Drive Silver Fox Drive from Caribou 1,000 feet towards Red Fox Lane Entire length of Caribou Drive Entire length of Cub Drive Bear Lane from Cub Drive to Mt Sheep Lane Mt Sheep Lane from Bear Lane to Lynx Drive

If approved, the estimated cost of the project would be amortized over a 10 year period. The tax rate of \$0.90 per thousand assessed would cover the annual payments. A home assessed at \$150,000 would be assessed approximately \$135 per year.

Measure 9-109 Arguments

Argument in Favor

We are writing today in support of ballot measure 9-109. With the increased cost of living that is happening in Bend that is forcing people to move outside the city limits, it is inevitable that our neighborhood will grow and become more populated. All of us purchased property in the neighborhood knowing the roads were gravel and dirt and not expecting it to change. After living here we have noticed a dramatic increase of traffic that has negatively impacted the quality of life for those of us who live here. The amount of dust that is created and that remains in the air during the dry seasons from the traffic on our roads has become more than a nuisance. Most of us relocated to this area to be able to enjoy the beautiful outdoors and wildlife of Deschutes County but that is no longer an option.

Beyond the dust factor, voting yes for this measure makes economic and financial sense as well. Each year thousands of dollars are spent trying to maintain broken roads. Money is spent on grading to try and fix potholes and smooth out the wash board road that last for only days or a few weeks at best before speed, poor driving behaviors and increased traffic destroys it again. Extra money is continuously being spent on car washes, alignments, tire balancing and air filters due to the washboard, potholes and dust that fill our roads and air. Our neighborhood would save money by not having to continually grade and gravel the roads that are included in this bond measure.

As current homeowners, we stand behind this ballot measure and believe it to be sound financially, environmentally and it will increase the quality of life in the place we call home.

Argument in Opposition

I oppose this bond measure for several reasons: Not all property owners are registered voters in Deschutes County and will have no voice in whether or not this bond will pass. Although they will see the increase in their property taxes. The road board made no effort to inform all 400 plus property owners of their intentions to put this on the ballot. • In our road district there are 7.2 miles of road and this measure would only put Otta Seal on 2.3 miles of road. So not all property owners will benefit equally, yet will be taxed the same as the owners that will have Otta Seal up to their driveways. • The proposed measure is for a single layer of Otta Seal who's life expectancy is 5-6 years, to extend that time to 9-11 years a sand seal would needed at an additional cost of over \$40,000. This would increase the project costs up over \$175,000. (Source: A Guide to the Use of Otta Seals, Aug 1999) Only one contractor currently in Deschutes County applies Otta Seal, so no competitive bids could be considered. This contractor has not applied Otta Seal to a major development before. The road board did not do their due diligence prior to deciding to put this measure on the ballot. No traffic studies were done to determine which roads are the most travelled in the district. Despite many property owners asking that a traffic study be done prior to putting this issue up for a vote. • This measure would increase the speed of automobiles while only eliminating a small percentage of the dust created. This increased speed would increase wildlife deaths also. The possibility of getting the rest of the roads paved with Otta Seal in the future is unlikely since the property owners that would benefit from this bond measure would likely not vote for an additional bond measure to complete the rest of the development's roads.

Measure 9-110 City of Bend

Ballot Title 9-110

Recreational Marijuana Sales Tax

QUESTION: Should Bend impose a 3% tax on the sale of recreational marijuana?

SUMMARY: This measure, if approved, would authorize Bend to impose a 3% tax on recreational marijuana sold within the City. The sale of medical marijuana to registered medical marijuana cardholders shall not be taxed.

If approved, proceeds from the tax will go to the City's general fund. Most of the general fund is spent on public safety, including police and fire services, but the general fund can be used for any city expenditure.

A copy of the Ordinance adopting the tax may be reviewed at City Hall or at www.bendoregon.gov.

If approved, the measure would take effect on January 1, 2017.

Explanatory Statement

The measure, if approved, would authorize the City of Bend to impose a sales tax at the rate of 3% on recreational marijuana sold by state-licensed marijuana retailers located in Bend. The sale of medical marijuana to registered medical marijuana cardholders shall not be taxed.

The proceeds from the measure are estimated to be \$345,600 for 2017. The revenue collected from the tax on recreational marijuana shall go to the general fund. Most general fund expenditures go to public safety, including police and fire services, but general fund revenue can be used for any City expenditure.

Oregon voters approved Measure 91 on November 2014, legalizing the sale and consumption of marijuana to adults 21 years of age and older. In 2015, the Oregon Legislature reduced the state sales tax on recreational marijuana from 25% to 17% effective January 1, 2017, and allowed local jurisdictions to ask for voter approval of a 3% local sales tax. ORS 475B.345 provides that a city council may adopt an ordinance imposing a 3% tax on recreational marijuana sold by retail licensees, but the council must refer that ordinance to the city's voters at a statewide general election.

If approved, the measure would take effect on January 1, 2017.

Ballot Title 9-11

Prohibits Recreational Marijuana Retailers in La Pine

QUESTION: Shall the City of La Pine prohibit recreational retailers in areas subject to the City's jurisdiction?

SUMMARY: State law allows operation of licensed recreational marijuana retailers. State law provides that a city council may adopt an ordinance to be referred to the voters of the city to prohibit (ban) the establishment and operation of recreational marijuana retailers. The La Pine City Council has referred this measure to the voters as provided under state law.

Approval of this measure will prohibit (ban) the establishment and operation of recreational marijuana retailers within any area subject to the city's jurisdiction.

If this measure is approved, the city will be ineligible to receive distributions of state marijuana tax revenues and will be unable to impose a local tax or fee on the production, processing, and/or sale of marijuana or any product into which marijuana has been incorporated.

Explanatory Statement

Approval of this measure will prohibit (ban) the establishment and operation of recreational marijuana retailers in the City of La Pine. Approval of this measure will not operate to prohibit (ban) recreational marijuana producers, recreational marijuana processors, recreational marijuana wholesalers, medical marijuana dispensaries or medical marijuana processors.

Measure 91, approved by Oregon voters in 2015, provides that the Oregon Liquor Control Commission will license recreational marijuana retailers. A city council may adopt an ordinance prohibiting (banning) the establishment and operation of recreational marijuana retailers within the city, but the council must refer the ordinance to the voters at a statewide general election. The La Pine City Council has adopted an ordinance prohibiting (banning) the establishment of recreational marijuana retailers within the city and, as a result, has referred this measure to the voters. If approved, this measure will prohibit recreational marijuana retailers within the city.

Approval of this measure has revenue impacts. Currently, ten percent of state marijuana recreational tax revenues will be distributed to cities to assist local law enforcement in performing their duties under Measure 91. Before July 1, 2017, the money is distributed in shares based on the population each city bears to the population of the cities in the state. After July 1, 2017, money will be distributed based on the number of licensees in the city, with 50% distributed based on the number of producers, processors, and wholesale licensees and 50% distributed based on the number of retail licensees. If approved, this measure would make the city ineligible to receive distributions of state marijuana tax revenues.

Currently, under the 2015 legislation, a city may impose up to a three percent tax on the sale of marijuana items by a marijuana retailer in the city. However, a city that adopts an ordinance prohibiting the establishment of recreational marijuana retailers may not impose a local tax on the production, processing, and/or sale of marijuana or any product into which marijuana has been incorporated. Therefore, approval of this measure will prevent the city from imposing a local tax on those activities.

Measure 9-112

City of La Pine

Ballot Title 9-112

Imposes City Tax on Retail Sale of Recreational Marijuana

QUESTION: Shall La Pine impose a three percent tax on the sale of marijuana by a licensed marijuana retailer?

SUMMARY: State law provides that a city council may adopt an ordinance to be referred to the voters of the city imposing up to a three percent tax or fee on the sale of certain marijuana items by a licensed marijuana retailer. The La Pine City Council referred this measure to the voters as provided under state law.

Approval of this measure will impose a three percent tax on the sale of marijuana items by marijuana retailers in the city. The tax will be collected at the point of sale and remitted by the marijuana seller.

Under state law, a city that adopts an ordinance prohibiting the establishment and/or operation of a recreational marijuana retailer may not impose a tax or fee on the production, processing, and/or sale of marijuana or any product into which marijuana has been incorporated. This measure will become operative only if the measure proposing to prohibit (ban) the establishment and operation of recreational marijuana retailers is not passed (approved) by voters.

Explanatory Statement

Approval of this measure will impose a three percent tax on the sale of marijuana items by a marijuana retailer within the City of La Pine. This measure will become operative only if the measure proposing to prohibit (ban) the establishment and operation of recreational marijuana retailers is not passed (approved) by voters.

Under Measure 91, adopted by the Oregon voters in November 2014 and amended by the Legislature in 2015, the Oregon Liquor Control Commission must license the retail sale of recreational marijuana. The 2015 Legislature provides that a city council may adopt an ordinance imposing up to a three percent tax on the sale of marijuana items (which includes marijuana concentrates, extracts, edibles, and other products intended for human consumption and use) by retail licensees in the city, but the council must refer that ordinance to the voters at a general statewide election. The La Pine City Council has adopted an ordinance imposing a three percent tax on the sale of marijuana items by a retail licensee and, as a result, has referred this measure to the voters.

Under state law, a city that adopts an ordinance that prohibits (bans) the establishment and/or operation of recreational marijuana retailers may not impose a tax or fee on the production, processing, and/or sale of marijuana or any product into which marijuana has been incorporated. As a result, if voters pass the prohibition (banning) ordinance, this tax measure will not become operative even if it also receives a majority of votes.

Measure 9-113 Ponderosa Pines East Special Road District

Ballot Title 9_113

Five Year Local Option Tax for General Operations

QUESTION: Shall Ponderosa Pines East Special Road District impose \$4500 each year for five years for general operations beginning in 2017/2018? This measure may cause property taxes to increase more than three percent.

SUMMARY: The taxes needed for five years total \$22,500, which will be imposed in equal amounts of \$4,500 each year. The tax revenue from this measure will provide revenues sufficient for the Ponderosa Pines East Special Road District to operate at its current level of service for residents within the boundary of the Ponderosa Pines East Special Road District.

Road Grading and Surfacing with Rock Snow Plowing Safety and Traffic Control Signs **District Insurance** Operating Expenses of the District

When the District was formed, the Board, with the advice from Deschutes County, determined the tax rate to be \$1.0469 per \$1000 of assessed value. This estimate included property along Rim Road that is NOT part of the District. After removing the Rim Road properties from the District, the District's remaining property value resulted in less tax revenue for the district.

This new rate would replace an expired levy rate. It is NOT in addition to the rate assessed for the expired levy which expired in 2011.

Explanatory Statement

When the Ponderosa Pines East Special Road District was formed, the Board, with advice from Deschutes County, determined the rate needed for the road district's goals to be \$1.0469 per \$1000 of assessed value. This rate of \$1.0469 per \$1000 of assessed value is the permanent rate and can only be changed through approval by a vote of the people of the State of Oregon in a statewide election.

The base map boundary establishing the district was drawn wrong and included property along Rim Road that is NOT part of the road district. After removing the Rim Road properties from Ponderosa Pines East Special Road District, Deschutes County reassessed the Road District's property values. This reassessment resulted in less tax revenue for the district.

Road District expenditures are anticipated to exceed tax revenues in the near future due to increased maintenance due to heavier traffic on roads and increased cost for snow plowing, district insurance, surface rock, road grading, and higher fuel costs. The proposed five-year local option tax will provide revenues sufficient to meet road improvement, snow removal, and safety issues for the near future.

This new rate will REPLACE the expired levy rate. It is NOT in addition to the levy rate that was assessed for the expired levy.






