

# **Deschutes County Candidate Election Information**

## May 19, 2026 Primary Election

First Day to File, September 11, 2025 Filing Deadline, March 10, 2026

## **Candidate Filing Process:**

### **Non-Partisan Positions:**

(See <u>Office & Election Requirements for County Candidates</u> reference sheet for election schedule, winning threshold, and other office requirements)

- County Assessor, 4-year term
- County Clerk, 4-year term
- County Commissioner Position 1, 4-year term
- County Commissioner Position 3, 4-year term
- County Commissioner Position 4, 2-year term
- County Commissioner Position 5, 2-year term
- County Sheriff, 4-year term
- County Treasurer, 4-year term

Filing period: September 11, 2025 to March 10, 2026.

- Filing by Declaration:
  SEL 101 Candidate Filing Major Political Party or Nonpartisan
  \$50 Filing fee
- Filing by Petition (500 Valid Signatures Required):

Before circulating, submit the following for County Clerk's written approval:

**SEL 101 Candidate Filing – Major Political Party or Nonpartisan** (mark the "Prospective Petition" box)

#### SEL 121 Candidate Signature Sheet/Nonpartisan

- After signatures have been collected, candidate submits the following to the County Clerk no later than 5 pm on the filing deadline:
  - SEL 121 Candidate Signature Sheet/Nonpartisan
    - Each signature sheet must be signed and dated by the circulator
  - SEL 338 Petition Submission Form
- Allow 10 days for the County Clerk's office to verify signatures.

### **County Voters' Pamphlet:**

If you are interested in submitting a candidate statement for the Deschutes County Voters' Pamphlet, complete the **2026 Candidate's Statement Form for Voters' Pamphlet**.

## **Campaign Finance Reporting:**

Each candidate must establish a campaign account designating a candidate committee unless the candidate meets all three of the following conditions:

- The candidate serves as the candidate's own treasurer
- The candidate does not have an existing candidate committee
  and
- The candidate does not expect to receive or spend more than \$750<sup>1</sup> during a calendar year

<sup>&</sup>lt;sup>1</sup> The \$750 includes personal funds spent for any campaign-related costs, such as the filing of candidacy fee. However, if at any time during a calendar year the candidate exceeds \$750 in either contributions or expenditures, the candidate must establish a campaign account and file a Statement of Organization within three business days. Additionally, all contributions received and expenditures made during the calendar year must be filed electronically not later than seven calendar days after the \$750 threshold has been exceeded.
