Re: Unrestricted Development of marijuana farms

I would like to begin by thanking you for the work you do on behalf of the citizens of Deschutes County. I also think it is important to state that we support options for people who suffer from PTSD, chronic pain, and the effects of chemotherapy and other serious illnesses. We are not anti-business and celebrate the creation of jobs in our county. With that understanding, we believe it is imperative that Deschutes County develop zoning restrictions or some serious enforceable guidelines for the volcanic eruption of marijuana growers in our county and specifically for Tumalo, in light of the push to make Tumalo, the 'Napa of Central Oregon Cannabis Country' with the focus on cannabis instead of wine.

We live in Tumalo and the best description of our immediate community is 'rural suburbia'. The parcels range in size from 2, 5, 10, to 20 acres and up. Most of the residents in our area could be considered people who have moved here for the view, the privacy, and the convenience to Bend. Their "farming" activities consist of power walking, running, biking, riding horses and walking their dogs. There are a few folks that raise hay for their own animals or irrigate to feed two or three steers raised for their own use. Some own a couple of horses for trail riding or eventing and others have a handful of free range chickens. About half of the people on our street just have a house on acreage with no intention of doing any activity other than enjoying their home. In fact, the last two parcels that sold are being built solely for the purpose of privacy and views.

On one end of Dayton Road is Hooker Creek Cutting Horse Ranch and Chimps Inc., Chimpanzee Sanctuary. On the other end is a little home where the owners are trying to develop a Bed and Breakfast with their one extra bedroom. The owners also have a little stand where they sell pickles, pies, eggs, and jam, and the neighbors leave their money and checks in a little locked box on the honor system.

Behind them, a former horse training business has exploded into a huge marijuana growing facility. This was never an agricultural property but now it has seven large greenhouses with

more under construction, a former large horse building converted for use in the new "industry" and there appears to be continuing development, with constant presence of heavy equipment and contractors trucks. All of this is occurring near a home recently purchased and being renovated as a country residence. Clearly this facility can be seen from the back deck of their home and has potentially diminished its property value. I have been told that the owners of this facility have expressed a desire to be the largest marijuana grower in the area. This is troubling and is totally out of character because our street is not agricultural by any stretch of the imagination. Within walking distance of our home are two more properties developing large greenhouses and there seems to be no end in sight or any consideration of the impact on the neighborhoods involved.

This uncontrolled development in areas that are not agriculturally focused will cause some serious consequences including a potential rise in crime, a drop in home values, and increased traffic where residents are used to enjoying a bike ride, taking their dog for a walk, or taking the baby out for a jog in the stroller, just to mention a few.

Please consider the impact on your constituents and the communities you represent, and come up with a plan where the marijuana growers can grow and harvest their crops in the outlying areas of the county where there are other large scale farming operations.

We have a very personal concern regarding this issue, as do our immediate neighbors. Our home and property is NW of Tumalo.
