1. Complete the application form and provide appropriate original signatures. To ensure timely processing of your application, all materials must be submitted on single-sided, 8.5" x 11" paper. Do not use binders, tabs/dividers, staples or tape.
2. Attach correct fee.
3. Provide one complete set of plans drawn to scale, including:
 - Dimensions of the proposed sign;
 - Dimensions of the existing signs on the property;
 - A plot plan that shows all property lines and existing and proposed signs, existing structures, parking, landscaping, lighting, etc. If color exhibits are submitted, black and white copies with captions or shading delineating the color areas shall also be provided.
 - Structural details of supports, framing, bracing and footings where applicable; and
 - Electrical equipment and lighting.
 - If this application includes oversized plans, copies no larger than 11" x 17" with graphic scale shall also be included. If color exhibits are submitted, black and white copies with captions or shading delineating the color areas shall also be provided.

Note:

- A separate application is required for each sign.
- Any sign with electrical wiring in or on the sign requires an electrical permit from the Deschutes County Building Safety Division.
- Signs over six (6) feet in height may require a building permit.
