


Casos en el condado de Deschutes por semana




Casos en el condado de Deschutes por grupo etario

Recuento diario de pacientes con COVID-19 hospitalizados actualmente (Datos del sistema de salud de St. Charles)




Recuento de casos semanal en el condado de Deschutes



Safer Ways to Enjoy the Super Bowl

Gathering virtually or with the people you live with is the safest way to celebrate the Super Bowl this year. If you do have a small gathering with people who don't live with you, outdoors is safer than indoors. This year, choose a safer way to enjoy the game.

- Host a virtual Super Bowl watch party.
- Make appetizers or snacks with the people you live with to enjoy while watching the game.
- Start a text group with other fans to chat about the game while watching.
- Attend an outdoor viewing party where viewers can sit 6 feet apart.




If you choose to attend the Super Bowl or a large Super Bowl event, like a watch party, follow these steps to make yourself safer:

- Call the venue to ensure that they have steps in place to prevent the spread of the virus.
- Follow signage at the venue to allow for social distancing.
- Arrive to the venue early to avoid crowding and congested areas.



Five things to know this week:



- Information about the characteristics of COVID-19 variants is rapidly emerging.
- In Oregon, the U.K. (B.1.1.7) and California (L452R) variants have been detected.
- Multiple variants of the virus that causes COVID-19 have been documented in the United States and globally during this pandemic.
- What we know is based on the evidence we have now and may change as new data emerges.
- Viruses constantly change through mutation, and new variants of a virus are expected to occur over time.

Phase 1A December 12, 2020

Everyone in Phase 1, Groups 1,2,3 and 4 are currently eligible for the vaccine.

Group 1

- Hospital staff with frontline patient care responsibilities
- Urgent care
- Skilled nursing and memory care facility healthcare personnel (HCP) and residents
- · Tribal health programs
- Emergency medical services (EMS) providers and other first responders
- All health care interpreters and traditional health workers in any setting within Phase 1a

Group 2

- Other long-term care facilities, including all paid and unpaid HCP, all staff and contractors, including residents who meet the age requirements of:
- Residential care facilities
- Adult foster care
- Group homes for people with intellectual and developmental disabilities
- Other similar congregate care sites
- Hospice programs
- Mobile crisis care and related services

 Individuals working in a correctional setting

Group 3

- HCPs in outpatient settings serving specific high-risk groups
- Day treatment services
- Non-emergency medical transport (NEMT)
- Paid or unpaid caregivers (including parents or foster parents) of medically fragile children or adults who live at home
- Adults and age-eligible children who have a medical condition or disability who receive services in their homes

Group 4

- All other outpatient HCPs
- Other HCP who provide direct service to people with I/DD and other high-risk populations.
- Other public health settings, such as HCP serving WIC, or CBO's with direct or indirect exposures

Subsequent groups will be determined in coordination with the Vaccine Advisory Committee and shared on OHA's COVID-19 vaccine web page. These are examples of groups of people who may included:

- Critical workers in high-risk settings — workers who are in industries essential to the functioning of society and substantially higher risk of exposure
- People of all ages with underlying conditions that put them at moderately higher risk
- People in prisons, jails, detention centers, and similar facilities, and staff who work in such settings
- General population



^{*} Oregon's vaccine supply is limited. It is estimated to take 12-15 weeks to vaccinate groups 1-5 of Phase 1B.

El Comité Asesor de Vacunación de Oregon hace recomendaciones finales

El 28 de enero, el Comité Asesor de Vacunación (VAC) contra el COVID-19 se reunió para su cuarta y última reunión oficial. Recomienda que se adelanten cuatro grupos simultáneamente ya que Oregon ha vacunado a una masa crítica de adultos mayores. Esos grupos serían:

- Adultos de 16-64 años con afecciones subyacentes
- Trabajadores de primera línea (a definir)
- Adultos y jóvenes en custodia mayores de 16 años
- Personas que viven en viviendas de bajos ingresos y de adultos mayores

Las personas que viven en hogares multigeneracionales serán las siguientes después de estos grupos, a lo que le seguirá la población general.

Como siguiente paso, el personal de OHA revisará las dimensiones operativas y legales de las recomendaciones antes de enviarlas a la gobernadora Kate Brown.




