#### Wrap Around Is...

A holistic and intensive team approach for meeting the needs of children, youth and families who face challenges related to mental health concerns and other complicated issues.

A strengths based, family driven approach that and acknowledges the expertise families bring to the problem solving process. Wrap Around gives families a voice in making decisions about their children's care.

A team process comprised of the whole family, professionals and agencies who come together to collaborate on a common goal for the benefit of the entire family.

A process expected to last at least 6 months and no longer than 18 months.

### What do you need know?

Family involvement is critical. Without family participation and agreement we cannot move forward.

Families will help develop the Wrap Around team and will participate in the decision making and planning process.

Family members will be asked to develop a list of strengths and needs and will work with the team to create a family goal and consider a variety of actions.

This is not just more of the same treatment process...we are going to look at what has worked and what hasn't worked and focus on what will help your family succeed.

#### Who may be eligible?

- Child & Family live in Deschutes County
- Child is 5 to 18 years of age
- Child is receiving services at Deschutes County Behavioral Health and has a diagnosed or emerging mental health condition
- Child may be at risk of out of home placement or already placed
- Child is served by multiple agencies/systems

### What is Intensive Chftdren's Treatment Services?

Intensive Community Treatment Services (ICTS) is a level of care within the continuum of services provided to children receiving mental health services and is part of the Children's System of Change Initiative. Our goal is to increase the availability and quality of individualized, intensive, and culturally competent home and community based services so that children can be served in the most natural environment possible and so that the use of institutional care is minimized.
