

## **Driving Tour**

#### December 01, 2021

    - o Roll call of authorized attendees, distribute map and route information
    - Guides will read same script
    - Proposers to submit all questions in writing, only items provided via addendum will be considered
- Ground rules by Lt. Mike Gill and Lt. Joe DeLuca (Deschutes County)
  - No weapons, electronics, cameras, medications

Buses exit Adult Jail parking lot

- 1. Sheriff's Office (aka "Station 10")
- 2. Adult Jail
- 3. SWAT Building
- 4. Secure Employee Parking
- 5. Public Overflow Parking

Turn right on Jameson

6. Stabilization Center and Secure Parking Lot (formerly Adult P&P)

#### Turn right on Poe Sholes

- 7. 9-1-1/OSP overflow parking
- 8. Deschutes Recovery Center (secure residential treatment)
- 9. 9-1-1 Dispatch and Oregon State Police facility

Turn right into Community Service Shop parking lot

- **10. New Community Service Shop**
- **11. Juvenile Detention**
- **12. Community Justice Center**

<u>Turn right in parking lot and proceed in front of Juvenile Detention/Community Justice Building.</u> <u>Proceed to front of Adult Parole & Probation and Work Center Building</u>

- **13.** Adult Parole and Probation (2<sup>nd</sup> Floor)
- 14. Sheriff's Office Work Center (1<sup>st</sup> Floor)
- 15. Site of future Adult P&P expansion. Expected completion summer of 2023.

Exit Adult P&P parking lot, right on Britta, right into Special Services Parking lot and circle through lot

16. Search and Rescue (SAR) / Emergency Services Building

**17. Automotive Shops** 

Exit parking lot, turn left on Brittta, turn left on Poe Sholes

#### 18. 9-1-1 Dispatch / Oregon State Police / Secure Parking

Turn Right on Service Road, proceed to cul-de-sac, pause

- 19. 9-1-1/OSP Maintenance Shop
- 20. Veterans' Village
- 21. Vacant "Hill" lot

<u>Circle cul-de-sac and return to Poe Sholes, turn right on Poe Sholes, left on Jameson, left into Jail parking</u> <u>lot. Park buses at Station 10 Lobby entrance</u>

## Deschutes County RFP # 2021-934 for A/E Services Walking Tour Notes

December 01, 2021

#### Sheriff's Office Administration Building (Station 10):

- Expand space for detectives and 1st floor administration unit.
- Expand evidence storage.
- Evaluate Maintenance and Accessory Storage buildings.
- Evaluate space for exercise and wellness facility.

#### Adult Jail:

- Improve front-of-house flow, expand personal visitation, expand confidential professional visitation
- Improve back-of-house flow at booking and administrative processing areas
- Introduce daylight in staff areas
- Expand the following inmate service areas: kitchen (>1,000 meals/day at top capacity), laundry (washing blankets currently outsourced), storage (inadequate), medical.
- Create/reconfigure direct-supervision male and female units.
- Improve efficiencies in parking areas.
- Boilers and chillers are original, approximately 50 rooftop units replaced 5 years ago, no DDC
- Mental health staff offices are in mezzanine
- Loading dock might be desirable, existing generator located in secure yard, existing rooftop crane serves three roofs
- Explore work release beds in future programming
- Current male/female adult capacity includes single, double and dorm configurations

#### Work Center

- Has served many functions over the years, currently not used as work center due to COVID
- Work center beds should be adjacent Adult Jail to share services, but populations will not mix
- Work Center expansion to southeast by approximately 8,000 SF
- Relocate "book and release" function to Adult Jail
