

INFORMATION SHEET Deschutes County Surplus Property Public Auction Friday, October 7, 2022

1. Check website for current details: www.deschutes.org/auction

- 2. Auction Location: Deschutes County Fair and Expo, located at 3800 SW Airport Way, Redmond, Oregon 97756
- 3. Date and Time: Auction will be on Friday, October 7, 2022 and starts promptly at 10 a.m. For those preregistered (see section 4 below), check-in starts at 9:00 a.m. Registration on the day of the auction also starts at 9:00 a.m. You must be registered and show ID to receive a bid card prior to the 10:00 a.m. auction start.
- 4. **REGISTRATION:** You must be registered to bid and there is no fee to register. Pre-registration must be received by October 6th at 12:00 p.m. (NOON).

- PRE-REGISTER In Person Option: You may register in person from Monday, October 3rd to Thursday, October 6th, from 9:00 a.m. to 12:00 pm. Bring completed registration to 14 NW Kearney Street, Bend, prior to NOON on October 6th. After this time, registrations should be brought to the auction site.
- **REGISTER Day of the Auction:** Print and bring a signed and completed registration form to the auction location, which opens at 9:00 a.m. Allow extra time to check-in, complete registration with ID, and receive a bid card before 10:00 a.m. No registrations allowed after 10:00 a.m.
- 5. **Cash or Cashier's Check ONLY.** The high bidder can leave to obtain funds, but must return before 2:00 p.m. to complete the sale. Make Cashier's Check to "Deschutes County Sheriff's Office".
- 6. **\$66 Buyer fee for each property** for Certificate of Sale and Notary fee, <u>due October 7th</u> by check, cash, or cashier's check to "Deschutes County Sheriff's Office".
- 7. **\$77 plus \$5 for each additional page for Buyer cost to record each Certificate of Sale** with the County Clerk's Office –required. Onsite station will be available.
- 8. **Deed Recording Fees**: Deed recording fees are included in the winning bid price, within 45 days of auction day.
- 9. Financing is available for property sold for \$20,000 or more.
 - Nonrefundable 20% down payment AND
 - Equal monthly payments over 10 years OR payoff in 30 days AND
 - Fixed interest at 6.50% AND
 - Each property is individually financed with no combination for separate properties allowed.
 - Prior to issuance of any building permits on financed property, the amount due/promissory note must be paid in full.
 - A W-9 Form will be collected at closing; Property Management will perform closing duties.
