Subject: Contract for Supplying and Hauling of Crushed, Pre-Coated Rock for Chip Seal 2020

NOTICE OF INTENT TO AWARD CONTRACT

On February 5, 2020, the Board of County Commissioners of Deschutes County, Oregon considered proposals for the above-referenced project. The Board of County Commissioners determined that the successful bidder for the project was High Desert Aggregate and Paving with a bid of Seven Hundred Fifty Nine Thousand Five Hundred Eighty Seven Dollars and Fifty Cents. (\$759,587.50).

This Notice of Intent to Award Contract is issued pursuant to Oregon Revised Statute (ORS) 279B.135. Any entity which believes that they are adversely affected or aggrieved by the intended award of contract set forth in this Notice may submit a written protest within seven (7) calendar days after the issuance of this Notice of Intent to Award Contract to the Board of County Commissioners of Deschutes County, Oregon, at Deschutes Services Building, 1300 NW Wall Street, Bend, Oregon 97703. **The seven (7) calendar day protest period will end at 5:00 PM on Wednesday, February 12, 2020.**

Any protest must be in writing and specify any grounds upon which the protest is based. Please refer to Oregon Administrative Rules (OAR) 137-047-0740. If a protest is filed within the protest period, a hearing will be held at a regularly-scheduled business meeting of the Board of County Commissioners of Deschutes County, Oregon, acting as the Contract Review Board, in the Deschutes Services Building, 1300 NW Wall Street, Bend, Oregon 97703 within two (2) weeks of the end of the protest period.

If no protest is filed within the protest period, this Notice of Intent to Award Contract becomes an Award of Contract without further action by the County unless the Board of County Commissioners, for good cause, rescinds this Notice before the expiration of the protest period.

BACKGROUND AND POLICY IMPLICATIONS:

Deschutes County Road Department ("Department") prepared solicitation documents for the Supplying and Hauling of Crushed, Pre-Coated Rock for Chip Seal 2020. The project was advertised in the *Bend Bulletin* on January 2 and January 9, 2020 and the *Daily Journal of Commerce* on January 3 and 10, 2020. Department opened bids at 2:00 P.M. on January 23, 2020.

Three (3) bids were received for this project. The bid results are as follows:

High Desert Aggregate and Paving, Inc	\$759,587.50
Tri County Paving, LLC	\$821,250.00
Green Dream	\$1,129,942.90
Engineer's Estimate	\$778,665.00

This action issues a Notice of Intent to Award the contract to the apparent low bidder, High Desert Aggregate and Paving, Inc., and allows seven days for a party to protest the award. If there is no protest within the seven-day period, the contract will be awarded to the low bidder. The bid tabulation, including the Engineer's estimate, is attached.
