### SUBJECT: District Formation Meeting #9

#### **Discussion Items:**

- Parker attended Redmond WWTP open house, seen as regional treatment solution, City staff is confident project will proceed and is supportive of interconnection with Terrebonne
- Dylan Stott introduction 4<sup>th</sup> board member, works for CO Truck Co. in Terrebonne, born and raised in Terrebonne, attended Terrebonne Elementary, interested in supporting positive community growth
  - o Suggested looping in Steven Myrin, Vet clinic owner, Dylan to reach out & confirm support
- Amin Patel introduction new commercial property owner, purchased >1 acre along Hwy 97, very supportive of sewer to support proposed food card business, holding title to property, awaiting county recording, his wife Mariah Patel is interested in board service.
- Formation petition approved by Clerk, 2 hearings were scheduled:
  - o 1<sup>st</sup> BOCC hearing (board issues order to form TSD): 10/5/22 at 9am, including testimonies from:
    - Chris Doty (County) brief project overview/kickoff, Redmond MOU, ODOT project
    - Guy Vernon (RRMH) represent 30 MH families, issues, project origins
    - Parker Vernon (RRMH) describe petition signature gathering and community support
    - Lauren Redman (Oliver Lemon's) describe septic issues, related costs, risks to store
    - Tim Brown (TSAG) TSAG meetings, 5 tentative board members, estimated timeline
    - Ryan Rudnick (Parametrix) explain feasibility study, proposed design, and financials
    - Todd Cleveland (County) describe history of septic issues in Terrebonne, DEQ/county rules
    - Steve Shropshire (JRPC) available to address any legal questions that come up
  - 2<sup>nd</sup> BOCC hearing: 11/2/22 at 9am (adopt order, officially forming TSD)

  - Convey risks to community and request County's political support as District pursues funding from other sources, may need to explore supplemental County funding sources in the future for design, construction, District administration, etc.

- Redmond IGA setup meeting in Fall once details are coordinated and 5 District board members ready

   Draft IGA needs to be finalized, some details subject to change in light of cost inflation, etc.
- ODOT project preliminary design phase, construction estimated for Fall 2023
  - \$1M Sewer grant must be spent by 6/30/2024, with or without ODOT project
- Terrebonne Sewer PER TSAG reviewed, address comments/finalize, provide link to read w/ pres. Matl's.
- Public outreach Lauren offered OL grocery for public outreach activities, soon after hearing is scheduled
- TSAG meetings going hybrid (virtual/in-person), Parametrix conference room & Teams, starting 10/20

County and City Candidates: Deadlines applicable to county and city office are not included on this calendar. Candidates for those offices, unless otherwise provided for by charter or ordinance, are elected at the primary or general election. If a county or city charter provides for candidates to be elected at an election other than the primary or general election but does not specify a deadline or adopts the statutory filing deadline, ORS 249.722 applies.

District Candidates: The enabling statutes, or principal act, of a district specifies how board members are elected. Most districts, as defined in ORS 255.012, elect board members at the regular district election which is held in May of odd numbered years or at the Primary or General Election. As provided for in ORS 255.235(2)(a), the March and September deadlines included above are only applicable if the election is a district's first election to elect board member and are not included in the daily calendar.
