## **Section G-Scope of Services**

Section G-Scope of Services for Knott Landfill Greenhouse Gas Reporting is amended to include reporting greenhouse gas emissions to the Oregon Department of Environmental Quality, as noted in *italics* as follows:

## **Knott Landfill Greenhouse Gas Reporting**

<u>Annual Greenhouse Gas Reporting:</u> The consultant shall complete the Knott Landfill annual greenhouse gas report and submittal using the US Environmental Protection Agency's e-GRRT online reporting tool *and the DEQ Greenhouse Gas EZ-Filer reporting program.* DCSW will furnish facility operating and site development data for inclusion in the submittal.

## **Cost Proposal Form**

The cost proposal form has been modified to reflect the current groundwater monitoring and reporting requirements for Southwest Landfill, consistent with the Southwest Landfill Solid Waste Disposal Site Closure Permit No. 259.

An additional section has been added to the Cost Proposal Form to include Title V and Greenhouse Gas calculations and reporting requirements.

An amended Cost Proposal Form is included with this Addendum.
