#### About the Department.....

The Department of Solid Waste oversees the management of solid waste in Deschutes County. Knott Landfill Recycling and Transfer Facility, the only landfill in the County, is estimated to remain open until 2029.

For waste disposal, we provide four Transfer Stations servicing outlying areas of Deschutes County. These include: Negus Transfer, located in Redmond, Northwest Transfer, between Bend and Sisters, Southwest Transfer, north of La Pine, and Alfalfa Transfer, located off Walker Road near Alfalfa.

Deschutes Recycling, located at Knott Landfill Recycling and Transfer Facility, and all four of our Transfer Stations provide full recycling opportunities. The collection company in your area may provide additional recycling drop off opportunities. Call (541) 317-3163 for more information.

#### **Secured Load Rebate**

A \$10 rebate is applied for refuse loads properly covered and secured in accordance with Deschutes County Ordinance 13.36.040.

#### **Material Definitions**

**Yard Debris:** leaves, grass, tree trimmings, and stumps. Yard debris must be free of dirt and rocks.

**Appliances:** (residential) refrigerators, freezers, ranges, dishwashers, air conditioners, washers and dryers.

**Wood Waste:** painted and stained wood, lumber, particle board, plywood, and waferboard (OSB). Nails are ok. **Excludes:** laminates like formica and melamine and creosote treated lumber. No large metal fasteners.

### **Items NOT accepted at Transfer Stations**

- Dirt, sod, concrete, rocks, bricks, and other inert material
- Hazardous materials
- Liquids
- Manure
- Ashes (dead or alive)
- Asbestos
- Other large or heavy items that may damage the transfer trailers as determined by the attendant on duty

Transfer stations may accept up to 4 cubic yards of construction debris. Larger amounts must come directly to Knott Landfill Recycling and Transfer Facility.
