1. Section 02150 - Clearing and Grubbing, C. Measurement and Payment is amended to read as follows:

No separate or additional payment will be made for Clearing and Grubbing, but shall be considered incidental to the work and shall be included in various unit or lump sum bid items.

- 2. Replace PART V, BID PROPOSAL FORMS, Bid Schedule, Page 2 with the attached revised Bid Schedule. Clearing and Grubbing has been deleted as a bid and pay item.
- 3. Section 02303 Crushed Area Stone, Road Stone and Gravel, C. Materials is amended to read as follows:
 - 1. Crushed Stone or Gravel for foundations, trenches, subbase course and Equipment Area. The materials shall be well-graded clean screened gravel or crushed stone. Sieve analysis shall be determined according to AASHTO T 27. The gradation shall be as follows: Maximum size shall be 1 ½ inch, 90-100% shall pass a 1-inch sieve, and no more than 5% shall pass a 3/8" sieve.
 - 2. Road Stone for trench backfill and surface restoration for the electric utility road crossing shall be furnished by the Owner for placement by the Contractor from an existing on-site stockpile.

Bidders are reminded that receipt of this Addendum must be acknowledged by the Bidder in the Acknowledgement of Addendums section that is shown on Page 3 of the Bid Proposal.
