

REQUEST FOR PROPOSALS DESCHUTES COUNTY DEPARTMENT OF SOLID WASTE HAZARDOUS WASTE TRANSPORTATION & MANAGEMENT SERVICES

The Deschutes County Department of Solid Waste is soliciting proposals from experienced and qualified firms for providing transportation and waste management services for Deschutes County's hazardous waste collection program. In general, the services to be provided include:

- Providing all staff, labor, materials, tools and equipment necessary for the transportation of household hazardous waste (HHW) and Very Small Quantity Generator (VSQG) materials from Deschutes County designated sites to appropriate hazardous waste management facilities.
- Providing and arranging for the appropriate management of all HHW and VSQG accepted from Deschutes County.
- Providing on an as-needed basis, personnel to assist in the operation of Deschutes County's HHW and VSQG collection programs.
- Providing packaging supplies to the County such as shipping containers (pails, drums, cubic-yard/meter boxes, IBC tanks, etc.), absorbents and other equipment and materials for the County's hazardous waste collection program as needed.

IMPORTANT: Prospective Proposers downloading/accessing website-posted solicitation documents, including this Request for Proposals and other related documents <u>MUST</u> complete and submit the Contact Information Form provided on the County's Bids/RFPs website (<u>www.deschutes.org/rfps</u>), to receive follow-up documents (addenda, response to questions, clarifications, etc.). <u>Failure to provide contact information will result in Proposer</u> <u>disqualification</u>.

This is not a contract offer and with this solicitation the Proposer assumes any liability for the costs incurred in the preparation and transmittal of proposals in response to the solicitation.

Award of this project will be based on criteria as described in this Request for Proposals and includes, but is not limited to, proposed fees, firm experience, qualifications and capabilities in hazardous waste transportation and management, staff experience, and references.

Proposals must be received by 4 pm PST on June 18, 2025 and are to be submitted using one of the following formats:
