Dear Deschutes County Voter:

This is your May 21, 2019 Special Election Voters' Pamphlet provided by your Deschutes County Clerk's office. It contains information about candidates and measures from local jurisdictions within the boundaries of Deschutes County.

This pamphlet contains the ballot measures and explanatory statements designed to provide impartial information. It also contains paid arguments for or against certain measures. Candidates may also pay to place a statement in the pamphlet.

Ballots will be mailed by Wednesday, May 1, 2019, to each registered voter. Here are a few things you should know:

- ♦ Voted ballots **MUST** be received at our office or an official drop site location by **8:00 pm**, **Tuesday**, **May 21, 2019** to be counted. Remember to sign your ballot envelope.
- ♦ Additional drop sites open Wednesday, May 15<sup>th</sup>. Check the Drop Site Location page in the pamphlet for more details.
- ♦ Candidate names on your ballot will appear in random alphabetical order. In accordance with ORS 254.155, random ordering of the letters is conducted prior to an election.
- Not all the candidates or measures in this Voters' Pamphlet will be on your ballot. Your residence address determines those districts for which you may vote. Your official ballot will contain only those issues on which you are eligible to vote, based on where you live.
- Not all candidates submit information for the Voters' Pamphlet so you may have candidates on your ballot that are not in the Voters' Pamphlet.
- This Voters' Pamphlet is online at <u>Deschutes.org/clerk</u>. After 8:00 pm on Election Night, preliminary election results will be posted online at <u>Deschutes.org/electionresults</u>.
- If a ballot was delivered to your residence for someone who should no longer be receiving a ballot at your address, please write "RETURN" on the envelope and place it back in your mailbox.
- The signature on each voter's ballot return envelope is verified against the voter's signature on file. The signatures must match before a ballot can be counted. If your signature has changed, please update your voter registration.

# Voting Information

### Registering to Vote

To be eligible to vote in the May 21, 2019 Special Election, a completed voter registration card must be postmarked by Tuesday, April 30, 2019.

#### To Register To Vote In Oregon, You Must Be:

- 1. A resident of Oregon.
- A United States citizen.
- 3. At least 18 years old by election day.

#### You Must Update Your Registration If:


- Your residence or mailing address changes. 1.
- Your name changes.
- You wish to change your party affiliation.

Important Note: If you have moved or your name has changed and you have not yet updated your registration, you are still eligible to vote. Contact the Deschutes County Elections office, 541-388-6547 for further information.

#### Voters With Disabilities:

If you are unable to vote your ballot without assistance, contact the Deschutes County Elections office at 541-388-6547. We will provide two persons to assist you in voting. To assure your voted ballot is received by election day, contact the elections office early to arrange for assistance. You may also select someone else of your own choice to assist you.

#### **Voting Instructions**

Your Ballot Packet should contain at the least the following items:

- ✓ Printed ballot
- ✓ A pre-addressed return envelope to be signed
- ✓ Secrecy sleeve

#### Examine your official ballot and vote it:

Examine your official ballot and locate the candidate or measure response oval of your choice for each contest. To vote you must blacken the oval ( completely with a pen (black or blue ink) next to your choices. Do not use a felt tip pen.

#### Review your ballot:

Ensure you correctly marked your choice for each contest. Your official ballot may contain contests printed on both sides of your ballot.

#### Prepare to return your ballot:

Place your ballot in the return envelope. You may use the optional secrecy sleeve, but it is not required. Election staff will ensure the secrecy of your ballot. Read the voter's statement on the return envelope and sign it on the signature line.

#### Signing your ballot return envelope:

Your ballot will not be counted if the return envelope is not signed. Every signature is checked against the registration signature on file and the signature must match for the ballot to be counted.

#### Return your ballot:

By mail: Attach first-class postage to the signed and sealed return identification envelope. Mail it as soon as possible to arrive at Deschutes County Elections Office no later than 8:00 pm on Election Day. Postmarks do not count.

At an official drop site: Deliver the signed and sealed return identification envelope to an official drop site no later than 8:00 pm on Election Day. Postage is not required if delivered to an official ballot drop site location.

Remember, review both sides of your ballot. Some ballots may have races/measures on both sides.



# How to cast your vote...

# Complete your ballot

- To vote, completely fill in the oval next to your choice with a pen (black or blue ink). Do not use a felt tip pen.
- To vote for a person not on the ballot, fill in the oval next to the "write-in" line, then neatly write the name of the person on the line provided. Don't write a candidate's name that already appears on the ballot.
- You do not have to vote on all contests. Those you do vote on will still count.



# Check for errors


- If you vote for more options than are allowed, your vote will not count for that contest.
- If you make a mistake on your ballot, you may make your changes on the ballot. Draw a line through the entire candidate name or measure response. You then have the option of making another choice.
- Contact Deschutes County Elections office at 541-388-6547 to request a replacement ballot if:
  - you make a mistake
  - your ballot is damaged or spoiled
  - your ballot is lost



# Using the optional "Secrecy" sleeve

If you use the optional "secrecy" sleeve, insert only your voted ballot (not another person's ballot) inside. Then, insert only your secrecy sleeve inside your ballot return envelope.

(If we receive an envelope with more than one ballot inside, all enclosed ballots are rejected and not counted)



# Measure 9-126 Redmond Area Park and Recreation District

#### **Ballot Title**

9-126

#### BONDS TO CONSTRUCT NEW COMMUNITY RECREATIONAL FACILITY TO EXPAND PROGRAMS

QUESTION: Shall Redmond Area Park & Recreation District, construct recreational facility, acquire land to expand programs by issuing \$40,000,000 in bonds? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

SUMMARY: If approved, general obligation bonds are expected to finance acquisition of land and construction of a new recreational facility anticipated to include:

- · Pools for swimming lessons, aquatic exercise classes, therapy, recreation and lap swimming
- Gymnasium for multipurpose programming use
- · Indoor walking/jogging track
- · Exercise facilities and equipment
- Group fitness room(s)
- Classroom and meeting space for recreation programming, events and meetings
- Administrative and support spaces including locker rooms, lobby and office space
- Other amenities
- Site improvements, demolition, furnishings, equipment and bond issuance costs

The District would establish a citizen oversight committee to ensure proceeds are used for purposes indicated.

Bonds would mature in not to exceed 20 years from issuance. Estimated tax rate is \$0.55 per \$1,000 of assessed property value. Estimated tax cost for this measure is an ESTIMATE ONLY, based on the best information available from the county assessor at the time of the estimate. Actual levy rate may differ due to changes in interest rates at the time of bond issuance and/or future changes in assessed valuations.

#### **Explanatory Statement**

The Redmond Area Park and Recreation District (the "District") was formed in 1975 and serves the greater Redmond community through a variety of recreation programs and facilities. The Redmond Area Park and Recreation District is requesting voter consideration of a bond measure to site design and construct a Community Recreation Center to be paid for by the issuance of a maximum of \$40 million in General Obligation Bonds.

The District currently operates the Cascade Swim Center and the RAPRD Activity Center. The Cascade Swim Center is a six lane 25 meter pool that opened in 1979 that provides community aquatic programming for the greater Redmond community. The RAPRD Activity Center provides group fitness classes, workout space, small classroom space and a half court basketball court in a leased facility. The lease for this facility is set to expire in 2022, and will not be renewed due to future city plans for roads and infrastructure.

This measure, if approved would authorize the District to expanded indoor recreation space for our community. The center will be approximately 66,000 square feet and is planned to include the

following amenities: a warm water leisure pool for swimming lessons, aquatic exercise classes, therapy, recreation and lap swimming; gymnasium for multi-purpose programming use; indoor walking/jogging track; exercise facilities and equipment; group fitness room(s); classroom and meeting space for recreation programming, events and meetings, as well as other amenities that are consistent with the recreation and aquatics needs of the community. This facility would allow for the expansion of recreation program opportunities for the community. The programs that are currently at the RAPRD Activity Center will be moved to the new community recreation center. The Cascade Swim Center would remain in use for competitive swim programs and lap swim.

If approved, the estimated annual average tax rate is approximately \$0.55 per \$1,000 of taxable assessed value. The 2018-19 median taxable assessed value of a home within the District boundaries is approximately \$200,000 resulting in an estimated annual cost of \$110 or roughly \$9.17 per month. The estimated tax cost for this measure is an ESTIMATE ONLY, based on the best information available from the county assessor at the time of the estimate. Actual levy rate may differ due to changes in interest rates and/or assessed value.

The District would establish a citizen oversight committee to ensure proceeds are used for purposes indicated.

The new facility will be home to a variety of valuable programs. Parents can use the cardio/weight room or enjoy fitness classes while children take swim lessons or play volleyball. Seniors will be able to socialize, exercise, and participate in programs to stay independent and healthy. Teens will have a positive, safer social space to recreate, and opportunities to learn new skills, like lacrosse, coding and cooking. Passing these measures helps Redmond meet critical recreation needs.

# Measure 9-127 Redmond Area Park and Recreation District

#### **Ballot Title**

9-127

#### FIVE-YEAR OPERATING LEVY FOR PARK AND **RECREATION**

QUESTION: Shall the District impose \$0.19 per \$1,000 of assessed value for operations for five years beginning in fiscal 2019-20? This measure may cause property taxes to increase more than three percent.

**SUMMARY:** The measure, if approved, would authorize the Redmond Area Park and Recreation District to levy taxes to support the annual operating costs for existing services, support the operation of District facilities and to expand programs for the citizens of the District. The measure would provide for a local option operating levy at a rate not to exceed \$0.19 cents per \$1,000 of taxable assessed value within the District for five years, beginning July 1, 2019. The proposed rate will raise approximately \$777,056 in 2019-20; \$800,368 in 2020-21; \$824,379 in 2021-22; \$849,110 in 2022-23; and, \$874,583 in 2023-24 for a total of \$4,125,496.

The estimated tax cost for this measure is an ESTIMATE ONLY, based on the best information available from the county assessor at the time of the estimate and may reflect the impact of early payment discounts, compression and the collection rate.

### **Explanatory Statement**

Redmond Area Park and Recreation District (the "District") was established on July 8, 1975, for the purpose of providing park and recreation facilities and activities for the residents residing within the greater Redmond, Oregon community. Currently, the District's facilities include the Cascade Swim Center, the Activity Center, the High Desert Sports Complex, Borden Beck Wildlife Preserve, and undeveloped parks at Majestic Ridge in Redmond and at Tetherow Crossing.

The District offers support for our community's health and wellbeing by providing fun, high-quality recreational experiences and activities for all. The District offers a variety of recreation programs including youth and adult sports leagues, STEM programs, cooking classes, art classes, music lessons, sports camps and swim lessons, among other programs and services.

In addition to this local option levy, the District has placed a general obligation bond measure on the May ballot for the purpose of financing the construction and related improvements of a new 66,000 square foot community recreation center which would accommodate a wide variety of multi-generational recreational, fitness, therapeutic, and enrichment activities. The tax revenue from this measure would be used to support the operation of this new facility including the operation of aquatic, wellness, and recreation programs.

The district presently has a permanent tax rate of \$0.3717 per \$1,000 of taxable assessed value and this additional levy would supplement the permanent rate to improve the recreation and fitness opportunities for the greater Redmond area.

If approved by the voters, the local option levy would be at a rate of \$0.19 per \$1,000 of taxable assessed value, beginning July 1, 2019 and lasting for five years. The 2018-19 median taxable assessed value of a home within the District boundaries is approximately \$200,000 resulting in an estimated annual cost of \$38.00 or roughly \$3.17 per month. The estimated tax cost for this measure is an ESTIMATE ONLY, based on the best information available from the county assessor at the time of the estimate. Actual levy rate may differ due to changes in interest rates and/ or assessed value. This measure may cause property taxes to increase more than three percent.

# Measure 9-127 Arguments

RAPRD is not run by or part of the City of Redmond government. RAPRD is an independent agency funded through property taxes and participation fees. It provides recreation services and facilities that thousands of Redmond area residents enjoy, but with its own budget and employees. RAPRD is run by--and financially dependent on--Redmond citizens. It's a hometown operation. Measure 9-127 will fund the new recreation center operation for the next five years.

Currently, RAPRD recreation facilities are the Cascade Swim Center, Activity Center, and High Desert Sports Field Complex. The Cascade Swim Center is forty years old and designed for populations one-fifth the size of Redmond. Cascade Swim Center operates at capacity and without up-to-date amenities it struggles to meet community needs. Having one pool limits the uses and availability for families, senior citizens, and teenagers alike. The leased Activity Center is tiny compared to facilities in towns much smaller than Redmond, and is slated for destruction with the City's streets expansion in 2022.

For the price of one weekly fast food meal or latte per home-around \$3-\$4 per household a week--these two measures give us better places to play, connect, stay healthy, and grow.



Immediate issues include class sizes, funding, teacher preparation time, and problems with technology. Graduation rates, improving remain somewhat low. Growth is pressuring buildings and facilities.

Taken individually: class sizes are an issue in management, learning and crowding. This problem should be addressed soon.

I have seen teachers that teach upto 4 classes in their school day. Not duplicates but as many as four differing preps. This is a problem: quality teaching requires more time for prep, fewer preps, and time for evaluation of lessons taught. I will address this issue, as appropriate.

Technology is a useful tool. Used as a replacement for paper texts, it is efficient and effective. Used in propagating social issues out of the schools, it becomes a psychological weapon: pressuring and not only school children, but teachers and parents. Social media can be divisive in schools and needs to be addressed. I will do that.

Communication between the schools and served population is difficult with a diversity as Bend/La Pine. Students and parents are often not aware of ALL the programs available. 




